

THE ULTIMATE SUPERUTES SUPERFAN COMPETITION

Terms and Conditions

- 1. The "Promoter" is V8 SUPERUTE SERIES PTY LTD (ABN 83 648 426 215). The Promoter and its related companies are referred to as the Promoter.
- 2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
- 3. Entry to the promotion is free and open to Australian residents who are 16 years of age or older by October 5, 2023, that enter their competition answer on either the category's official Facebook or Instagram social media post that declares the competition open.
- 4. Entry to the promotion is open until 5pm on Sunday October 1, 2023.
- 5. Only one answer per entrant will be factored into the prize draw.
- 6. Directors, managers, agents, employees of the Promoter and their immediate families are not eligible to win any prizes resulting from this promotion, as are any customers identified by the Promoter.
- 7. The winning entry will be drawn by the Promoter on Sunday October 1, 2023 at 6pm AEST in Sydney, Australia. The Promoter reserves the right to alter the respective Promotion Period, owing to any early or late changes to any of the respective event dates published by the Supercars Championship.
- 8. The Promoter's decision as to who is in receipt of the prize is final and no correspondence will be entered into to amend the decision.
- 9. The Promoter will attempt to notify the winner via social media direct messaging immediately after the draw.
- 10. If a Contestant is unable to be reached after within 24 hours of the draw time, then that person's right to being a Contestant and winning the prize is forfeited and the Promoter will conduct an additional draw at the same place as the original draw in order to select a contestant for the competition as determined by us in our absolute discretion, subject to any directions given by a responsible authority under any relevant legislation. In the event that a further draw is required, the Promoter will also attempt to notify the subsequent winning entry via social media direct messaging until a responding winner is reached.

 - Daily private meet and greet with V8 SuperUtes drivers

 - 1 x pitlane access pass during V8 SuperUtes sessions with use of a radio headset
- 12. In the event Contestants do not attend the Repco Bathurst 1000 at the date and time in which they have been drawn to participate, then that person's right to being a Contestant and winning the prize is forfeited and the Promoter will conduct such further draws as are necessary in order to select a Contestant for the competition as determined by us in our absolute discretion, subject to any directions given by a responsible authority under any relevant legislation.
- 13. To enter the draw for a chance to win, participants need to write their answer to "Tell us why you are our #1 V8 SuperUtes SuperFan in 25 words or less" on either the category's official Facebook or Instagram social media post that declares the competition open.
- 14. The following conditions apply to the prize:
- a. The prize is limited to those outlined in clause 11, and any additional costs or charges must be paid by the winner; such as but not limited to any costs associated with redeeming the prize such as travel, meals other than lunch provided, accommodation, spending money or taxes.
- b. The prize is limited to persons who are 16 years of age or older;
- c. The prize winner must do everything required of them to accept and take delivery of the prize within a reasonable period of time;
- d. If the prize (or a component of it) is not available for any reason, the Promoter reserves the right to substitute the prize with another of similar value, or at its discretion;
- e. The right to the prize is not transferable or assignable to another person; and
- f. The right to the prize is not exchangeable for a cash sum.
- 15. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
- 16. If the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, the Promoter may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.



- 17. The Promoter accepts no responsibility for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the promotion. Any cost associated with participating in the promotion are the entrant's responsibility.
- 18. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law.
- 19. The winning Contestant agrees to complete a Pit Lane Disclaimer from in order to have access to the Mount Panorama circuit pitlane, and agrees to follow all instructions given by the Promoter and/or its representatives during such sessions. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the element of the prize in which the Contestant is in pitlane.
- 20. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
- 21. The Promoter reserves the right to delay, modify or cancel (if need be) any aspect of this promotion if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures, inclement weather event or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned. This also includes the Promoter having the right to cancel the promotion in the event that the Promoter, in its sole discretion deems that it is unsafe to carry out any or all of the activities involved in the promotion.
- 22. By participating in the promotion, the winning Contestant authorises the Promoter, and contractors and agents of the Promoter, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter and its contractors and agents, for the purposes of (i) conducting the promotion and (ii) providing the entrant with information about the event; and (iii) making arrangements for a prize winner to be notified and receive their prize. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information.
- 23. The winning Contestant agrees to the use of their image and participation in any publicity associated with the promotion in perpetuity.
